## **TERMS AND CONDITIONS**

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entrants are only open to Australian residents aged 18 years or over.
- 3. Employees (and their immediate families) of the Promoters, and agencies associated with this promotion are ineligible to enter.
